

**Christmas Giveaway (“Promotion”)
Terms and Conditions of Entry (“Terms”)**

1. Participation in the Promotion constitutes acceptance of these Terms.

This Promotion is held at Springvale Homemaker Centre, 917 Princes Hwy Springvale (“Centre”).
2. The Promotion commences on Tuesday 19 November 2019 at 9.00am and closes on Tuesday 24 December at 11.59am.
3. To enter the Promotion, entrants must share a photo to either Facebook or Instagram showing the entrant participating in Springvale Homemaker Centre’s Christmas activities (Winter Wonderland, Santa Photos, Christmas Decorations or Letters to the North Pole installation. The post must:

 - ii. Posts must be visible to public to be eligible.
