

**Summer at Springvale Giveaway (“Promotion”)
Terms and Conditions of Entry (“Terms”)**

1. Participation in the Promotion constitutes acceptance of these Terms.

This Promotion is held at Springvale Homemaker Centre, 917 Princes Hwy Springvale (“Centre”).
2. The Promotion commences on Thursday 14 January 2021 at 7.00am and closes on Tuesday 26 January at 11.59pm.
3. To enter the Promotion, entrants must complete one of the below actions.
 - (a) Sign up to receive the Springvale Homemaker Centre as part of the Summer at Springvale sign-in process.
 - (b) Share a photo to either Facebook or Instagram showing the entrant participating in the Summer at Springvale activation. The post must:

 - ii. Posts must be visible to public to be eligible.
